Susan reviewed the School Bus Parking Report, dated December 19, 2016, from The Engineering Corporation (TEC), summarizing the parcels that were considered as possible school bus parking sites and the criteria used. TEC recommended the 4 most advantageous parcels, after categorizing the parcels into 3 groups. The Committee agreed to enlist TEC to conduct cost estimates and drawings for these parcels. The parcels include 0 River Road, 357 Commonwealth Road, Claypit Hill Road and 0 Pemberton.

5. Executive Session:

Upon a motion duly made by Ellen Grieco, seconded by Barb Fletcher, the School Committee <u>voted</u> unanimously (4-0) to enter executive session at 7:03 p.m. for the purpose of discussing strategy with respect to and in preparation for collective bargaining with Police, Fire, AFSCME1, AFSCME 2, Library, Teamsters, WTA, WESA, Custodial and Food Service Unions representing Town and School employees as permitted by M.G.L. c.30A, §21(a)(3), as such discussion in open meeting may have a detrimental effect on the bargaining position of the School Committee and an Executive Session is necessary to protect the bargaining position of the School Committee. Susan provided the School Committee with a note from the Director of Conservation. The Director of Conservation expressed concern with the site near the landfill due to the wetland designated area and a prior Order of Conditions.

Susan also provided information about another possible site at HDR Holdings, an office building off of Route 20, where spaces could be rented on a short-term or long-term basis. The Committee requested that Susan collect rental costs and any other terms from the owner.

Susan agreed to review the recommended parcels with First Student and explore splitting the buses between sites. She also will reach out to St. Ann's about using their parking lot during the weekdays.

The Committee decided to include the Middle School parcel in developing cost estimates.
