3. McKibben Demographic and Enrollment Forecast Report & Presentation

Arthur introduced Dr.Jerome McKibben of McKibben Demographic Research, LLC who presented a ten year demographic study that was done for the school department. Dr. McKibben began by noting that this study is a forecast and not a projection, and he explained

the difference. He noted that for forecasts, assumptions are needed. He reviewed the assumptions used in the Wayland study and the resulting forecasts. He noted that the study should be reviewed and updated after the completion of the 2020 census.

Arthur discussed the next steps including discussing the study with the principals, a review of kindergarten enrollment and the buffer zones, and a study of the need and location for additional classroom space.
