### I. PURPOSE OF MEETING

The subcommittee met to continue the review of Jim Hardy's recommended policy amendments from MASC as part of the "health check" or audit of the WSC Policy Manual.

# III. MASC Health Check of SC Policy Manual

The Committee reviewed each of the policies for which Jim Hardy at MASC recommended revisions and agreed upon appropriate action steps (e.g. bring to SC, follow up with certain Administrators etc.). The Committee discussed certain other policies that it decided to review. See attached updated status report, dated "as of 1/18/13".

The Committee discussed the following policies which have been previously published for public comment, and should be finally reviewed by the SC:

Barb will place these on a future agenda of the SC for review in light of public comments, if any, and approval.

Pursuant to a discussion , Barb will submit to the SC for discussion, publication for public comment, and approval by the SC of these policies at a future SC meeting:

The Committee reviewed JJF, Student Activity Accounts policy, and amended it given Geoff MacDonald's suggested change. Barb moved to bring the revised policy to the school committee for public comment and consideration. Beth seconded the motion. A vote to approve the motion was unanimous, 2-0.

The Committee received from Marlene Dodyk suggested changes to JLCA, Physical Examination of Students. The policy will be reviewed at the next meeting of the subcommittee.

Further follow-up concerning certain specified policies will be undertaken by Beth, in some cases with further input from administrators or Jim Hardy: AC, ADDA, ADDA et al, Section B, BEDC, BEDF, and JFABB; Barb will follow up as to other policies which are currently being reviewed by administrators.

The Committee discussed the process for developing a Medical Marijuana policy, which included reaching out to MASC, researching other communities and states for sample policies, reviewing the student handbooks and having discussions with certain Administrators.

### **III. Next Steps**

The Committee agreed to schedule another meeting in late January or early February to continue its review of said policies.

#### IV. Adjournment

Motion was made by Barb Fletcher, seconded by Beth Butler to adjourn at 12 PM. The vote was unanimous, 2-0.
